OVERVIEW

REPRESENTATIVE CASES

Defended commercial food producer in adversary proceeding in bankruptcy court. Client purchased assets from the bankruptcy estate of another food producer. Plaintiff owned property where assets had been stored and alleged that our client committed timber trespass, conversion, and was generally negligent when removing purchased assets from the property. Successfully defended client to favorable settlement.
